

Buska's Medallion Hunt Official Rules

- 1. Eligibility:** Buska's Medallion Hunt ("Contest") is open to legal residents of either the 50 United States or the District of Columbia. **Participants must be 21 years of age or older as of the beginning date of this contest in order to qualify. Younger hunters may help in the search for the medallion if accompanied by an adult.** Buska Retirement Solutions Inc.'s employees, subsidiaries, affiliates, and Medallion Hunt partners (collectively the "Releases"), as well as members of a Releases' immediate family and/or those living in the same household of Releases are ineligible to participate in the Contest. By participating in the contest, You grant permission for the Sponsor to use Your likeness and name for purposes of advertising and trade without further compensation unless prohibited by law.
- 2. Sponsorship.** The sponsor is Buska Retirement Solutions Inc. ("Sponsor"), located at 1818 Grand Avenue, Wausau, WI 54403. The Sponsor will conduct the Contest substantially as described in these Official Rules. Questions about the Contest can be sent to Info@RetireWithBuska.com.
- 3. Agreement to Rules:** By participating in the Contest, the Entrant ("You/Your") agrees to abide by the Sponsor's Official Rules and decisions, which are fully and unconditionally binding in all respects. The Sponsor reserves the right to refuse, withdraw, or disqualify any participant at any time at the Sponsor's sole discretion. By participating in the Contest, You represent and warrant that You are eligible to participate based on eligibility requirements explained in the Official Rules. You also agree to accept the decisions of the Sponsor as final and binding as it relates to the content of this Contest.
- 4. Contest Period:** This Contest begins on Monday, August 5, 2024, at 8:30 am CT and ends once the official medallion is found ("Contest Period").
- 5. The Medallion:** The official medallion ("Medallion") is 2" in diameter, made of bronze, and has the Buska "B" logo engraved on the front and a message engraved on the back. There are a total of 6 clues to the medallion's location. The first clue will be posted by 8:30 am on Monday, August 5, 2024, and at the same time each day thereafter until the medallion has been found. The daily clues and updates will be posted on the Sponsor's Facebook page.
- 6. The Location:** The medallion will be hidden somewhere in the greater Wausau area on property that is accessible to the public. It is NOT hidden in a residence or on residential private property. No trespassing is allowed on posted private land or restricted areas. It may be hidden indoors or outdoors and may not be accessible 24 hours a day. Please observe the posted hours of any location you may be searching. No digging, scaling, climbing, disassembly, or ransacking is required to find the medallion. The medallion will not be hidden within 10 feet of any body of water or road or in any other dangerous location. The medallion will not be hidden in locations not open to the public such as a storage area, breakroom, kitchen, or behind a service counter. The medallion will not be hidden in a public bathroom. Please be respectful while searching. At no time should participants put themselves or others in danger to find the medallion. If property is damaged or if the medallion hunt is being disruptive in any way, the Sponsor reserves the right to cancel the Contest entirely.
- 7. How to Enter:** The Contest has no official entry form. Participate in the Contest to enter – no purchase necessary. Eligible participants must fully meet all Contest requirements, as specified in the Official Rules, in order to be eligible to win the prize. Those that do not adhere to the Official Rules or specifications will be disqualified at the Sponsor's sole discretion.
- 8. Prizes:** One prize will be given away for this Contest. The Winner of the Contest (the "Winner") will receive a collection of gifts and gift cards/certificates with a total value of \$1,050. The actual/appraised prize value may differ at the time the prize is awarded. The prize(s) shall be determined solely by the Sponsor. The Winner, upon acceptance of the prize, is solely responsible for all expenses related to the prize, including without limitation any and all local, state, and federal taxes. - 10. Selection and Notification of Winner:** This Contest will have one Winner. The Winner will be the first Entrant to find the Medallion. To claim the prize, the Entrant must message the Sponsor via Facebook Messenger within 2 hours of finding the Medallion. **The message must include the name of the person who found the Medallion, the location where the Medallion was found, the date and time the Medallion was found, and images of the Entrant with the Medallion at the location where it was hidden.** Once a Winner has been verified by the Sponsor, a Facebook post will announce that the Medallion has been found. The Sponsor will officially notify Winner by email within 1 business day following Winner selection. The Winner must bring the Medallion to the Buska Retirement Solutions office during regular business hours within 3 business days to complete the Declaration of Compliance and Release and collect the prize. The Sponsor is not responsible for nor shall have no liability for Winner's failure to receive notices due to email security

settings that may cause notifications to be marked as spam or junk email. Nor shall Sponsor be liable for the Winner's provision of incorrect or otherwise non-functioning contact information. If the Winner 1) fails to claim the prize within 3 business days from the time the award notification was sent, 2) is found ineligible, or 3) does not complete and return an executed Declaration of Compliance and Release within the specified timeframe, the prize may be forfeited and return of the found Medallion will be required. Individuals who tamper with or attempt to tamper with the operation of the Contest or Facebook page or violates these Terms & Conditions will be disqualified by the Sponsor in its sole discretion. Attempts by any entrant to deliberately damage the Facebook page or undermine the legitimate operation of the Contest may be a violation of criminal and civil laws.
